#### January 2021 Newsletter- Searching for Purpose

Happy New Year! I hope we are enjoying this season that God has gifted to us to celebrate, even though we have had a tough year. Thinking about this newsletter, I got inspired by Luke's gospel, chapter 2: 41-52. It is the story of Jesus at 12 years of age, accompanying his parents to Jerusalem for the festival of the Passover according to the custom. Scripture reports that after the festival was over, while his parents were returning home, the boy Jesus stayed behind in Jerusalem. After three days, they found him in the temple courts, sitting among the teachers, listening to them and asking them questions. They questioned his choice to stay behind in the temple while they searched for him, to which he responded, "Why were you searching for me? Didn't you know I had to be in my Father's house?

While Jesus' parents search for him, he too is searching; Jesus is on a search for a different thing. He is discovering his mission as the Son of God. He is sitting at the feet of the rabbis asking all the questions that have been lingering in his mind, then going silent and pondering what he heard, and then asking more questions. #### St Paul UMC Administrative Council Minutes Zoom Meeting December 15th, 2020

In attendance: Pastor Susan Murithi, Mikaleh Esquitin, Carrie Hancock, Mary Ann Rickertsen, Deb Wells, Dave and Nancy Harrington, Darla Voigt, Dave Snow, and Tom Powell.

Pastor began the meeting at 7:00 pm with a prayer.

Mikaleh entertained a motion to accept the October minutes. Mary Ann made a motion, and Tom seconded. Motion passed.

**Pastor's report**: Pastor reported on how the year has been going. She wanted to thank the Safety Team for all the work they have been doing. She has been trying to do as many visits as she can at this time. She stressed to continue to keep in touch with people in the church (from our Care Members list) especially those that are having health/other challenges. The Youth group has been doing great, even though it is suspended at least until the new year. The Youth in the community have really enjoyed it. The Charge conference this year was very different this year, only lasting approximately 20 minutes. Carrie is working on getting the Charge Conference booklets put together. The Wednesday Prayer group has been learning lots of ways to pray differently. It will conclude on Dec. 16<sup>th</sup> for the fall session. The Howard County Emergency manager dropped off about 4 dozen smaller bottles of sanitizer for church use. We shouldn't need sanitizer for a while, thanks to them. Pastor is planning on having Consecration Sunday in January some time. Also, some baptisms will be done in January, so if anyone knows of a family that would like a child baptized to please let Nancy or Pastor know.

Pastor Susan said she would like each committee to create a vision or goal for the new year, what they hope to achieve. As this is nothing the committees have done in the past, please feel free to ask Pastor Susan for guidance.

**Finance:** Treasurer's report was given by Tom Powell: Operating Checking account \$20,599, Trustees Maintenance Acct. \$5,548, Resources Available \$63,712, Giving \$16,206, Total Income \$37,154 Total Expenditures \$14,607, Current Month Gain/(Loss) \$22,547 and the Year to Date Gain/(Loss) is \$18,161. Tom mentioned that the PPP Cares Act Loan that we had received from the government this year has been forgiven. Mikaleh entertained a motion to accept the Treasurer's report. Deb made a motion, Darla seconded. Motion passed.

Carrie reported what Francine had reported on pledge cards from her report in Finance.

Francine had reported that she had received about 20 pledges so far. Some people had increased their amounts in giving, but she also said that a few of the members who gave on a regular basis had passed away. Carrie also reported that the milk fund currently has about \$185 in it, and the Children's fund (for Heifer International) has \$369.30. This leaves approximately \$130 to reach their goal of \$500 to purchase a heifer for a needy family. Pastor really wished that we could reach this goal and get that money sent out soon. We may use some of the Christmas Eve offering to go to this goal.

**SPPRC:** Pastor reported on how the custodians are doing. They seem to be doing a fairly good job, with a few issues that they correct as they are notified. Susan also mentioned that the SPPRC met in October and had decided to give her a raise. After consideration on Pastor Susan's part, she then decided to hold off on it and to re-evaluate later on in 2021 as the finances were unsure at this time.

**Trustees:** Carrie reported that she had received the taxes for the parsonage for 2020. The total for this is \$2,635.96. In last week's Finance meeting it was decided to pay these out of the Trustees Maintenance account, as this is where the rent from the renter's was being put into. Carrie also reported that the fridge in the church kitchen is not cooling again. Janet Thomsen had called Restaurant Supply (where it was purchased) and a repairman had come out, refilled it with freon, but said it most likely has a leak somewhere. Janet was going to call back and see where to go from there.

<u>Memorial</u>: Deb reported that the Advent Candles and wreath had been received, and they are beautiful. She also said that they will be giving out scholarships from the Memorial account soon.

*Education:* Nancy reported that instead of a Christmas program this year, they would do a Christmas Scavenger hunt. They are hoping to involve more of the community.

The teachers are still rotating Sundays for Sunday School, with two teachers each Sunday, one for each age group. The Youth Group is not meeting right now, and with the Covid situation will be re-evaluated in January to see if they will be able to meet safely.

**<u>Mission/Outreach</u>:** Mary Ann reported that the Boo Bash was a better turn out than they expected, passing out about 400 bags to kids. Dave Snow reported on the Christmas Cheer program. They had 15 families and 31 children, and it is going very well. The families will need to pick up their goods on December 18<sup>th</sup> from 10-2. <u>Office</u>: Carrie reported that she received the agreement from Paul Mueller's office for 2021. This cost will go up from \$250/month to \$265/month. During the Finance meeting, it was voted on to go ahead with this agreement for 2021. Carrie also wanted to let everyone know she received the forms necessary for the parsonage to be exempt next year, since Pastor Susan is now living there. After discussion, and speaking with the County Assessor's office, everyone was okay with Carrie filling out and signing these forms. They are due Dec. 31<sup>st</sup>. <u>Worship:</u> Darla reported that the pumpkins for Fall décor were from Plackes this year. The Christmas décor was put up by the Worship committee, and seemed to work smoothly. Nancy asked about if the Safety committee needed to do anything extra for Christmas eve. There was a discussion on how many people we might expect, and what our capacity is during this time.

**Old Business:** None that hasn't been discussed

**New Business:** There was discussion on the Christmas Eve offering that will be collected. Epworth Village came up, as well as the Food Pantry. Pastor Susan stressed the children's fund only needing \$130 more dollars, and that this may be an option also. Pastor knows of several ministries in Kenya that are needing help, including orphaned children.

Pastor also had a detailed report on her research for the parsonage. These were her findings:

The discussion was first brought up at the August 11<sup>th</sup>2020 Finance meeting by Brenda Starkey.

Brenda brought up that the church will need to decide something on the parsonage soon, whether a short term or a long-term basis. She was asked to make a proposal (as a Co-chair on the Trustees committee) to bring to Admin Council on the different ways the church could go on this topic. (See this Proposal attached to the September Ad Council meeting minutes in the church office). At the September Finance/Admin Council, Brenda's proposal had 4 main ideas:

Sell and replace with a more modern/updated home when/if available

Remodel (\$25,000-\$30,000) and sell down the road (5+years)

Sell and build new next to church

Sell and just pay monthly stipend of \$1,000 (All proceeds from the sale of a parsonage-can ONLY be used for a new parsonage or for rental stipend)

The house was assessed at \$135,500, and could realistically get \$150,000-\$160,000. The question came up as how much the church could handle 'loan wise'. At September's Ad council meeting, Brenda proposed to the Ad Council that they work toward the immediate repairs (Master Bathroom remodel, adding an Egress Window, fixing electrical outlets). The Finance had recommended that the current parsonage be sold and a new parsonage be bought, but everyone was in agreement that this is something that needs to be thought about and discussed. At the time of the September Ad Council, it was decided to bring up again at future meeting(s). Pastor Susan, at that time, touched base with the DS Lance.

He recommended to the church that we check the Great Plains website for Guidelines in this matter. He made some crucial points, including calling attention to the Book of Discipline of the UMC. In the case of the purchase of a parsonage, the Board of Trustees shall either:

Purchase a parsonage that is on ground floor level: a) One room that can be used as a bedroom by a person with a disability; b) One fully accessible bathroom; and c) Full accessible laundry facilities.

OR

Purchase a parsonage without the accessible features for people with disabilities specified above and remodel within one year's time. The requirements provide a basic standard of living which parsonage families reasonably expect in every appointment.

There were several routes to go from here including: Talk to people who builds houses and get their insights, if church members could help with the building? As in Labor? What are the city codes in extending the house, even an older home? Another option would be there are some premade homes that may save some money.

Things to consider in this situation: The homes need to be ADA Compliant- check parsonage standards on the Great Plains website. If it comes to selling the current parsonage, Tom Lucas will come and approve it. If we agree to build a house and needs more than 20% on top of the money we have, we will need a church or charge conference to discuss it because it requires a financial commitment from the members. The church would need to gather documents needed from the last 3 years, make sure there is a healthy pattern of giving. From the information from builders and Real estate professionals, Pastor Susan found out these insights: Building a new house is not a good choice at this time. Prices have sky-rocketed.

The cost of 1700-2000 sq. feet would cost between \$200,000-\$250,000.

Building that same house would take \$300,000.

Lots right now are going for around \$15,000-30,000. We could sell a portion of the church lot to help pay for some (maybe \$20,000).

Church labor would help, but may hinder the process as well. It may be wise to wait for some time before we build, give us an opportunity to figure our funding.

Buying would be a good option. In St. Paul, it is easy to sell a house, but not so easy to find one, so this will need to be taken into consideration. Maybe building a house at a later time would be a good option. This is the conclusion on Pastor's report on the parsonage at the meeting.

After Pastor's Susan report, the idea on trying to find a place to rent for the pastor to live in would be difficult, so a lot of people did not like that idea. Pastor's one major concern for the near future with the parsonage was the condition of the lawn/grass. It is very dry and in bad condition. She would like see something done in the next year. Discussion followed on this.

The topic of the parsonage will be something that will be brought up at future meetings to discuss further. As the new year approaches and our committees are changing, Carrie brought up that a letter to Citizens bank to change authorization for signatures needs to be done. Mikaleh made a motion to add Dave Snow and remove Evan Carlson from all of the church's Citizen's Bank accounts. This would allow Dave Snow to sign checks and have access to the bank accounts for the church. Dave Harrington made a motion and Mary Ann seconded. Motion passed. It was agreed that Tom Powell would stay on the accounts and therefore he can continue to sign checks as needed.

Meeting adjourned at 8:52 pm. Next meeting January 19th, 7:00 pm
