## St Paul UMC Administrative Council Minutes

May 6th, 2021

In attendance: Pastor Susan Murithi, Mikaleh Esquitin, Carrie Hancock, Deb Wells, Bob and Francine Rasmussen, Mary Ann Rickertsen, Dave and Nancy Harrington, Janet Thomsen and Dave Snow.

Mikaleh began the meeting at 7:05pm with a prayer. Mikaleh entertained a motion to accept the March 2021 minutes. A clarification on a portion of the minutes was needed. In the SPPRC portion it was stated that there would be a wage increase for both Pastor Susan and Carrie Hancock. A clarification was made in the March 2021 minutes. The minutes earlier read; "This would be an increase to Carrie's of \$500/year and Pastor Susan to what our previous Pastor (Russ) was making, which adds up to approximately an increase of \$2,000/year." Dave Harrington made a motion to amend the statement to read as follows " This would be an increase to Carrie by 500 \$ and to Pastor Susan by 2,000 \$ per year for 2021" Mary Ann seconded to have this change made. Dave Snow made a motion to accept the updated March minutes, and Bob Rasmussen seconded. Motion passed.

**Pastor's Report:** Susan reported the numbers for worship have been good, with an average of 56 in March for attendance, and 62 an average in April. She stated that a few new families have been attending. She was wanting to have an interactive session with these families, where she can explain what it means to be a member of the church, and see if they might be wanting to join. She proposed a Fellowship time with them and some members of the Ad Council for a shared meal. Most members proposed the 23<sup>rd</sup> at 6pm would work best. Carrie will work on getting a Sign-up Genius to the group to sign up for different food items.

Pastor Susan also suggested to have a couple people who could stand at the door when people are leaving church, and make contact with new people/families and welcome them/give them a church brochure, etc.

Susan stated that she is planning on having a Confirmation class in the Fall, and that she has approximately 5 kids interested in joining this. She pressed to please let her know if anyone else would be interested as soon as possible so the correct number of materials can be ordered. She wants to have mentors (adults) available for these children, so if you may be interested in this please let her know.

Good Friday and Sunrise service went very well, with quite a few people showing up.

Pastor said that the Prayer Group will start up again this Wednesday, May 12<sup>th</sup>. They will be doing things a little different, with different leaders and activities. For example, maybe a prayer walk or visiting the nursing home.

**Finance:** Treasurer's Report: The Treasurer's report was given by Dave Snow:

Operating Checking account \$15,067 Trustees Maintenance Acct. \$2,912 Resources Available \$62,669, Giving \$12,029, Total Income \$12,452, Total Expenditures \$14,481, Current Month Gain/(Loss) (\$2,029) and the Year-to-Date Gain/(Loss) is (\$1,151).

Dave stated that he received an updated number for the UM Foundation balance- the available balance being \$15,786 and the total is \$69,176. Deb had a question about the Memorial account and the \$100 dollars that were added into the Memorial and also an expenditure of \$100. Francine will check with her records at home and see if she can see any correspondence between the two things. She will be in contact with Carrie on this. Dave Snow entertained a motion to approve the treasurer's report. Dave Harrington made a motion and Janet seconded. Motion passed. Francine let everyone know that \$1,500 went to the Rudolf family after the death of Josh Rudolf. Francine and Carrie will get together on this also to see what additional money needs to go to the family, as an amount of \$1,300 had already been given to help with an unexpected bill and to the Rudolfs (Jannea).

**SPPRC:** Bob let everyone know that Carrie's hours will change with summer. She will now work Tuesday-Wednesday from 9am-1pm, and Thursday 9am-3pm (with an hour lunch).

**Trustees:** Janet reported that she herself didn't know exactly where it is with the parsonage lawn and well, but assumes it is progressing. The egress window is in, and Darwin Lee has himself paid for this. He also will be helping with the master bathroom installation in the parsonage. Our thanks go to him for his generosity!

Janet also mentioned that the church fridge has not been cooling correctly for some time. Midwest Restaurant supply was up on Tuesday, May 4<sup>th</sup> to look at it. She said that the repairman said the coils need to be replaced. The coils are under warranty and are ordered, but we would still need to pay for the service call, mileage, etc. She wanted to know everyone's opinion as to where to go from there. Pastor said she had spoken to the repairman and said that this was a big disappointment. She told him we did not want this fridge anymore, as it is a faulty piece of equipment and what could they do to replace it? The repairman said he would bring this back to their marketing director to see what could be done. He also said that he has had this happen before and the manufacturer replaced the entire equipment. Janet said she would call the next day and see where this is at with the company.

Pastor stated that she could report on the well for the parsonage. She said that Greg Rasmussen came to look at the well and he said the motor was good, but he said he would need to put in a bigger one to take care of the whole lawn. He also said that the parsonage didn't have a reservoir tank. There was discussion that maybe it would not need a reservoir tank. It was also discussed that the sprinklers could be put in even while waiting on the new motor. Janet will check with Darwin and maybe Roger Goettsche (who we had a bid from to do sprinklers) and see the progress of this.

**Memorial:** Deb reported that two scholarships were given from the church, one to Logan Vogel and one to Gunnar Nyberg. These will not go out to them until next semester (next year). There was an additional graduate that may have turned in a scholarship, but the application didn't make it in time, at least to Deb. She will look into this and see if it needs to be done yet. There is time, since it isn't awarded until second semester.

Deb also reported that they are looking at buying some more banners for the sanctuary. They said they paid for the care of the Memorial circle- like pruning of the plants and additional mulch.

Dave H. mentioned maybe the Memorial could help pay for the parsonage sprinklers. Deb said that she could bring it back to the Memorial committee and see what they thought. Nancy asked if the purchase of a feather flag could come out of Memorial. This flag could be used for a lot of things done in the community.

**Education:** Nancy reported that the Blessing of the Bikes is, for the most part, in place. It is planned for May 21<sup>st</sup> at 2:00 (the kids get out at this time) at St. Mark's Lutheran Church across from the school. There will be 5 stations like what had been done in 2019. Safety, the Blessing, Obstacle Course, Decorating, and Tune up. Joe Swanson will be helping with the safety again, and a fire truck and ambulance will be there. Help is needed at the obstacle course. The streets will be blocked off to help for this event. Dave and Nancy H. will work on a half-sheet pamphlets to hand out to the kids at the school, for both Blessing of the Bikes and for VBS. Nancy ordered 212 lights that attach to the bike handlebars. These cost \$338, which will be split with St. Mark's. The only other cost for this event will be if anything needs ordered for the 'Blessing' part of the Bike Blessing. They will be making quite a few sheets to hand out at school, so they will need colored paper for this. Carrie suggested seeing what the office has to use for these. Pastor asked where the money for these things should come from. It was decided to take it out of Outreach. Nancy mentioned that the Chamber of Commerce sent out an email requesting donations as a part of this event that will go to the bike shop, as he (John Rogers) donates not only his time, but he buys helmets, tubes, etc. In this email they also asked for volunteers if anyone wants to help.

Nancy also reported that May 16<sup>th</sup> would be the last day for Sunday School, and the Youth group will be done the 12<sup>th</sup>. She also asked where the money for scholarships to camp came out of in the past. Mary Ann thought the UMW. It has been a while since anyone went to camp.

**Mission/Outreach:** Mary Ann reported that the Neighborhood Mic Night will be on Sept. 12<sup>th</sup>. She was told by Steven Neal, the pastor of St. Mark's, that they have \$350 'seed' money from their church to go towards this, whatever is needed. Mary Ann also reported that she will be going on a mission trip this year to the Alabama coast. This will be June 5<sup>th</sup>-13<sup>th</sup>. She was asked if our church could furnish some things. It's a list of mostly paper and plastic items. It was decided to make a list and see what people could supply. There will also be a basket if anyone wanted to donate any money to this cause. Thank you Dave H. for making the needed items list and the flyers!

Mary Ann also reported that at the Nyambene Child Ministry in Kenya, where our Christmas offering went in 2020, that the kids performed really well on the testing they needed to do to get into secondary school. Pastor Susan reported that High school in Kenya is not free, and most of them are boarding schools. These tests help in their placement in the schools. Mary Ann said that the Ministry was able to place 8 out of the 20 kids that tested, but 12 are still needing help. It costs \$300/child to get into these schools. She knows that we cannot pay all of the amount for all the students, but that we could definitely figure out a way to raise money to help them out with these costs.

**Worship:** Darla had sent her report to Nancy as she was unable to make it to the meeting. Nancy reported for her on several items. See Darla's report as follows:

**Media:** Mike has done a great job of preparing the audio visuals for our worship service. After Doug and I visited with Mike this is our current plan:

\*At this time, Mike and Calee use a calendar as a schedule. They write down on each date if they will be in attendance or if they will be gone on that given Sunday. Then we can determine the needs accordingly.

\*Mike will train Calee and Doug to run the Live Stream equipment in case there is a Sunday that Mike has to be gone.

\*Calee, Doug, and Carol Phillips can currently run the easy worship system.

**Acolytes:** We have six youth that are currently interested in serving the church as acolytes. They are a very important part of the worship service so it is great that we have these youth to serve in this role. Darla has provided instruction for those new acolytes.

**Paraments:** The changing of paraments and flowers will occur at the end of the Easter season. Carrie will change the alter and the worship committee will put in new floral arrangements in the vases. June 6<sup>th</sup> will be the first Sunday in the beginning of the next church season.

**Banners:** Theda Van Horn will change as needed. We will assist if she needs it.

**Ushers, Greeters:** We will continue to assist Carrie with filling these roles when the council determines it is safe to do so.

**Scripture Reader:** There is still a sign-up sheet for this role on the table by the entrance. The worship committee will need to find a way to encourage more ways to get people to volunteer for this role in our service.

At the end of this report, Dave H. asked if there was a way that the Communion verbiage on the slides instead of having to read from the hymnals. This will be looked at and see if it is possible to place these words on slides so that it will flow easier in worship. Dave H. also asked if the communion elements were available to the people in the nursing home/assisted living. Pastor Susan said she thinks that with the lifting of some of the Covid restrictions that this will be taking care of itself.

**Office:** Carrie just asked how everyone was liking the newsletter. She stated that if anyone would like to see any changes/additions to please let her know. She said that she will probably be putting June and July together since the summer is slower at the church.

**Old Business:** The Fellowship Hall audio seems to be working now. There was a problem with it during a funeral and it wasn't working. It was mentioned that the speakers in the kitchen worked but not in the Fellowship Hall. It may be that the speakers are getting old.

**New Business:** Nancy brought up that maybe a fund needs to be available for the Youth Meals. It takes a lot of money and time to make these meals as it is such a large group. A meal could easily add up to being \$100/meal. Everyone thought that \$50/meal would be a good amount to help them with it. It was decided that this would be a good idea and a fund should be available through the office. This info should be in the email asking for meal sign up so that people know this is available. A campaign may be started this summer to collect money from individuals who would like to give to this cause, but they themselves don't want to do the meal. Any money for this will be kept in Education.

Francine spoke on Covid restrictions. She didn't know of anything new recently on restrictions. Pastor said there was nothing new on the Conference website. She was thinking that on May 23<sup>rd</sup> masks would be made optional, and a sign up for Usher/Greeters could start up again. We will set out the Registration booklet and have people sign either on the way in or the way out, with a hand sanitizer nearby to use after signing. The topic of Communion was discussed in depth, and it was decided to hold off on doing anything differently until maybe in July. Carrie brought up Fellowship a while later in the meeting and it was decided to look at it later in the summer also (August).

Nancy reported that they have decided on having a Vacation Bible school. This would be on July 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup>. They would try to incorporate GCA days, which is the following weekend, and have the kids help decorate a float for the parade on Saturday. This would be in conjunction with St. Mark's once again. It would work well with each church taking a day to plan. This would most likely include some kind of snack and perhaps a small breakfast item. Nancy asked if the UMW might be able to help supply some food items. She stressed that if anyone is willing to help with this, please let her or the pastor know. An announcement in church will be made and some volunteers are needed.

Dave S. mentioned that the Annual Conference will be happening at the end of May, and this will be done by Zoom. The General Conference will be next year sometime.

Mikaleh entertained a motion to adjourn the meeting. Dave S. made a motion, and everyone was in agreement to adjourn. The meeting adjourned at 9:10 pm. Pastor ended the meeting with a prayer.
